THE CITY OF THE CONFERENCE

City of Meerut (pop. app. 1.5 million) is located in the Indian State of Uttar Pradesh. It is an ancient city with settlements dating back to the Indus valley civilization having been found in and around the area. The city lies 70 km northeast of the

national capital New Delhi. It is also close to the now city *Hastinapur* – the place where the *Mahabharata* took place. Meerut is the second largest city in the National Capital region, and as of 2011, the 33rd most populous city of India. The city is one of the largest producers of sports goods, and the largest producer of musical instruments in India. The city is also an education hub in western UP. It is famous for being the starting point of the first revolution of independence against the British rule in 1857.

TRANSPORTATION FROM THE AIRPORT TO THE VENUE AT CCSU:

Participants are advised to reach the venue in India latest on the night of 24th/25th November 2018. For the arriving participants of the Conference, on the night of 23/24th and 24/25th a free transport will be arranged, **provided an arrival information is made available to the hosts sufficiently in advance.**

ACCOMPANYING GUESTS:

If you are travelling to the venue with an accompanying person, please inform the hosts in advance.

ACCOMMODATION:

Accommodation will be available in nearby hotels (Broadways and Harmony Inn) on preferential rates. All guests will be required to bear the cost of their stay at the hotel.

CLIMATE & CLOTHING:

The weather is mostly sunny with clear skies at this time of the year. Temperatures vary around 23-degree Celsius. Early mornings and evenings are cool thus light woolen clothes are recommended.

TRAVEL DOCUMENTS AND PERSONAL INSURANCE:

All foreign citizens coming to India must have in their passports a valid visa, issued by the Indian Embassy in their respective country. Also, travelers to India are advised to have health and other insurance policies as they deem fit.

CURRENCY REGULATIONS:

Participants are advised to change the foreign currency on the airport upon arrival. Indian currency is the Rupee. The rate of exchange is 1 USD = 65 INR. All payments

are made in local currency. Credit cards are accepted at places (but look for the signs or ask the owner of establishment).

Foreign citizens can carry into India, a maximum amount of cash worth 10.000 USD. However, Indian Rupee Notes cannot be taken out of the country.

SIGHTSEEING:

Costs of sightseeing will have to be borne by the participants. Through tourist agency, the Organizers will help to arrange a trip to AGRA-JAIPUR-DELHI and back to the airport during November 28th to 2nd of December. Those interested must inform the hosts sufficiently in advance.
