### Summary

**Zvonimir Šafranko, PhD** is a research and teaching assistant at Department of Law, Faculty of Economics & Business University of Zagreb. He graduated (*Magister iuris*) in 2005 and earned his PhD title in 2016 at the Faculty of Law, University of Zagreb. He worked in Valentino Moda Ltd. from 1997 to 2005 as a whole sale officer. After graduation, he volunteered for half a year at the Municipal Court in Zagreb and since 2006 was employed at the Commercial Court in Zagreb. He passed the Bar Exam in 2008. Since 2010 he has worked as an assistant at the Department of Law, Faculty of Economics University of Zagreb. As a part of his teaching activities he holds seminar classes in Commercial and Company Law, International Trade Law, European Market Law and European Company Law. He is also external associate at Faculty of Organisation and Informatics and Faculty of Electroengineering and Computing, University of Zagreb. He was speaker, moderator and actively participated in several round tables and international conferences. From 2011 to 2015 he was director (executive) in Valentino Moda Ltd. Since 2013 he participates in the Tempus project INTEREULAW EAST - European and International Law Master Program Development and Eastern Europe. He is technical editor in INTEREULAW EAST Journal.
